INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT

Re: Credit Agreement originally dated as of November 26, 1997 (as amended, modified or otherwise supplemented from time to time, the "Credit Agreement") among Desa International, Inc., Desa Holdings Corporation, the Lender Parties as parties thereto, Bank of America, N.A., as Administrative Agent, Banc of America Securities LLC, as Syndication Agent and Co-Arranger, and UBS Securities LLC, as Documentation Agent and Co-Arranger.

Ladies and Gentlemen:

Reference is made to the above-captioned Credit Agreement and to the Intellectual Property Security Agreement referred to therein (such Intellectual Property Security Agreement, as in effect on the date hereof and as it may hereafter be amended, supplemented or otherwise modified hereafter from time to time, the "Intellectual Property Security Agreement"). Capitalized terms not otherwise defined herein shall have the same meanings as specified therefor in the Credit Agreement or the Intellectual Property Security Agreement.

SECTION 1. Grant of Security. The undersigned hereby assigns and pledges to the Administrative Agent for the ratable benefit of the Secured Parties, and hereby grants to the Administrative Agent for the ratable benefit of the Secured Parties, a lien on and security interest in, all of its right, title and interest, whether now owned or hereafter acquired, in and to all of the Intellectual Property Collateral of the undersigned, wherever located, whether now or hereafter existing, including, but not limited to, the property and assets of the undersigned set forth on the attached supplements to the Schedules to the Intellectual Property Security Agreement.

SECTION 2. Security for Obligations. The pledge and assignment of, and the grant of a lien on and security interest in, the Intellectual Property Collateral by the undersigned under this Intellectual Property Security Agreement Supplement and the Intellectual Property

Security Agreement secures the payment of all of the Obligations of the undersigned now and hereafter existing under or in respect of the Loan Documents (including, without limitations, any extensions, modifications, substitutions, amendments or renewals of any or all of the foregoing Obligations), whether direct or indirect, absolute or contingent, and whether for principal, interest, premium, fees, indemnification payments, contract causes of action, costs, expenses or otherwise. Without limiting the generality of the foregoing, this Agreement secures the payment of all amounts that constitute part of the Secured Obligations and that would be owned by the undersigned to the Secured Parties under the Loan Documents but for the fact that they are unenforceable or not allowable due to the existence of a bankruptcy, reorganization or similar proceeding involving the undersigned.

SECTION 3. Supplements to Intellectual Property Security Agreement

Schedules. The undersigned has attached hereto supplements to each of the Schedules to the Security Agreement, and the undersigned hereby certifies, as of the date first above written, that such supplements have been prepared by the undersigned in substantially the form of the Schedules to the Intellectual Property Security Agreement and are complete and correct in all material respects.

SECTION 4. Obligations Under the Intellectual Property Security Agreement.

The undersigned hereby agrees, as of the date first above written, to be bound as a Grantor by all of the terms and provisions of the Intellectual Property Security Agreement to the same extent as each of the other Grantors. The undersigned further agrees, as of the date first above written, that each reference in the Intellectual Property Security Agreement to an "Additional Intellectual Property Collateral Grantor" or a "Grantor" shall also mean and be a reference in any of the other Loan Documents to a "Grantor" or a "Loan Party" shall also mean and be a reference to the undersigned.


SECTION 5. Governing Law: Jurisdiction: Etc. (a) This Intellectual Property Security Agreement Supplement shall be governed by, and construed in accordance with, the laws of the State of New York.

(b) The undersigned hereby irrevocably and unconditionally submits, for itself and its property, to the nonexclusive jurisdiction of any New York state court or federal court of the United States of America sitting in New York City, and any appellate court from any thereof, in any action or proceeding arising out of relating to this Intellectual Property Agreement Supplement, the Intellectual Property Security Agreement or any other Loan Document to which it is or is to be a party, or for recognition or enforcement of any judgment, and the undersigned hereby irrevocably and unconditionally agrees that all claims in respect of any such action or proceeding may be heard and determined in any such New York State court or, to the extent permitted by applicable law, in any such federal court. The undersigned irrevocably and unconditionally waives, to the fullest extent in may legally and effectively do so, any objection that it may now or hereafter have to the laying of venue of any suit, action or proceeding arising out of or relating to this Intellectual Property Security Agreement Supplement, the Intellectual Property Security Agreement or any other Loan Document to which it is or is to be a party in any New York state or federal court. The undersigned hereby irrevocably waives, to the fullest

extent permitted by law, the defense of an inconvenient forum to the maintenance of such action or proceeding in any such court. The undersigned hereby agrees that a final judgment in any such action or proceeding shall be conclusive and may be enforced in other jurisdictions by suit on the judgment or in any other manner provided by applicable law. Nothing in this Intellectual Property Security Agreement shall affect any right that the undersigned or that the Administrative Agent or any of the other Secured Parties may otherwise have to bring any action or proceeding relation to this Intellectual Property Security Agreement Supplement, the Intellectual Property Security Agreement or any of the other Loan Documents to which it is or is to be a party, or otherwise to proceed against the undersigned, in the courts of any jurisdiction.

(c) THE UNDERSIGNED HEREBY IRREVOCABLY WAIVES ALL RIGHT TO TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM (WHETHER BASED ON CONTRACT, TORT OR OTHERWISE) ARISING OUT OF OR RELATING TO THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT, THE INTELLECTUAL PROPERTY SECURITY AGREEMENT, ANY OF THE OTHER LOAN DOCUMENTS, ANY DOCUMENTS DELIVERED PURSUANT TO THE LOAN DOCUMENTS, THE TRANSACTIONS CONTEMPLATED HEREBY OR THEREBY OR THE ACTIONS OF THE ADMINISTRATIVE AGENT OR ANY OF THE OTHER SECURED PARTIES IN THE NEGOTIATION, ADMINISTRATION, PERFORMANCE OR ENFORCEMENT THEREOF.
