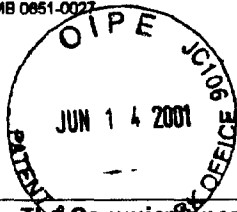

13 THIS AGREEMENT is made between

14  
15 Fleet Retail Finance Inc. (in such capacity, the "**Administrative Agent**"), a Delaware  
16 corporation with offices at 40 Broad Street, Boston, Massachusetts 02109, as agent for a  
17 syndicate of revolving credit lenders and a term lender (collectively, the "**Lenders**")

18 and

19  
20 Gym-mark, Inc. (hereinafter, the "**Borrower**"), a California corporation with its principal  
21 executive offices at 700 Airport Boulevard, Burlingame, California 94010

22  
23 in consideration of the mutual covenants contained herein and benefits to be derived herefrom,

24 *WITNESSETH:*

25  
26 1. **BACKGROUND:** The Administrative Agent and the Borrower and others have entered in a  
27 certain Loan and Security Agreement of even date (as such agreement may be modified, supplemented,  
28 amended or restated from time to time, hereinafter, the "**Loan Agreement**") pursuant to which a credit  
29 facility has been established in favor of the Borrower and under which the Borrower's Liabilities are to be  
30 secured by certain of the Borrower's assets, including all Marks. (Terms used herein which are defined in  
31 the Loan Agreement are used as so defined).

32  
33 2. **GRANT OF SECURITY INTEREST:** To secure the Liabilities, the Borrower hereby creates a  
34 security interest in favor of the Fleet Retail Finance Inc. (the "**Collateral Agent**") a Delaware corporation  
35 with offices at 40 Broad Street, Boston, Massachusetts 02109 for the ratable benefit of the Agents and the  
36 Lenders, with power of sale (which power of sale shall be exercisable only following the occurrence of an  
37 Event of Default) in and to the following and all proceeds thereof (collectively, the "**TM Collateral**):

38 (a) All of the Borrower's now owned or existing or hereafter acquired or arising  
39 trademarks, trademark applications, service marks, registered service marks and service mark

1 applications including, without limitation, those listed on **EXHIBIT A** annexed hereto and made a part  
2 hereof, together with any goodwill connected with and symbolized by any such trademarks, trademark  
3 applications, service marks, registered service marks, and service mark applications.

4 (b) All renewals of any of the foregoing.

5 (c) All income, royalties, damages and payments now and hereafter due and/or  
6 payable under and with respect to any of the foregoing, including, without limitation, payments under all  
7 licenses entered into in connection therewith and damages and payments for past or future infringements  
8 or dilutions thereof.

9 (d) The right to sue for past, present and future infringements and dilutions of any of  
10 the foregoing.

11 (e) All of Borrower's rights corresponding to any of the foregoing throughout the  
12 world.

13  
14 3. **PROTECTION OF MARKS BY BORROWER:** The Borrower shall undertake the  
15 following with respect to each items respectively described in Section 2(a) and 2(b) (collectively, the  
16 "**Marks**");

17 (a) Pay all renewal fees and other fees and costs associated with maintaining the  
18 Marks and with the processing of the Marks.

19 (b) At the Borrower's sole cost, expense, and risk, pursue the prompt, diligent,  
20 processing of each Application for Registration which is the subject of the security interest created herein  
21 and not abandon or delay any such efforts.

22 (c) At the Borrower's sole cost, expense, and risk, take any and all action which  
23 Borrower deems desirable to protect the Marks, including, without limitation, but subject to Borrower's  
24 discretion, the prosecution and defense of infringement actions.

25  
26 4. **BORROWER'S REPRESENTATIONS AND WARRANTIES:** The Borrower represents and  
27 warrants that:

28 (a) **EXHIBIT A** includes all of the registered trademarks, Federal trademark  
29 applications, registered service marks and Federal service mark applications now owned by the Borrower.

30 (b) All TM Collateral is and shall remain, free and clear of all liens, Encumbrances, or  
31 security interests to any Person other than to the Collateral Agent.

32 (c) The Borrower shall give the Administrative Agent written notice (with reasonable  
33 detail) within Ten (10) days following the occurrence of any of the following:

34 (i) The Borrower's obtaining rights to, and filing applications for registration  
35 of, any new trademarks, or service marks, or otherwise acquires ownership of any newly  
36 registered trademarks, registered service marks, trademark applications, or service mark

1 applications, (other than the Borrower's right to sell products containing the trademarks of others  
2 in the ordinary course of Borrower's business).

3 (ii) The Borrower's becoming entitled to the benefit of any registered  
4 trademarks, trademark applications, trademark licenses, trademark license renewals, registered  
5 service marks, service mark applications, service mark licenses or service mark license renewals  
6 whether as licensee or licensor (other than Borrower's right to sell products containing the  
7 trademarks of others in the ordinary course of Borrower's business).

8 (iii) The Borrower's entering into any new trademark license agreement or  
9 service mark license agreement.

10  
11 **5 AGREEMENT APPLIES TO FUTURE MARKS:**

12 (a) The provisions of this TM Security Agreement shall automatically apply to any  
13 such additional property or rights described in Section 4(c), above, all of which shall be deemed to be and  
14 treated as "Marks" within the meaning of this TM Security Agreement.

15 (b) The Borrower hereby authorizes the Collateral Agent to take all such action to  
16 protect the Collateral Agent's interest in and concerning any future registered trademarks, trademark  
17 applications, registered service marks and service mark applications, written notice of which is so given,  
18 *provided, however*, the Collateral Agent's taking of such action shall not be a condition to the creation or  
19 perfection of the security interest created hereby.

20  
21 **6. BORROWER'S RIGHTS TO ENFORCE MARKS:** Prior the Administrative Agent's giving of  
22 notice to the Borrower following the occurrence of an Event of Default, the Borrower shall have the  
23 exclusive right to sue for past, present and future infringement of the Marks including the right to seek  
24 injunctions and/or money damages, in an effort by Borrower to protect the Marks against encroachment by  
25 third parties, *provided, however*.

26 (a) The Borrower first provides the Administrative Agent with written notice of the  
27 Borrower's intention to so sue for enforcement of any Mark.

28 (b) Any money damages awarded or received by the Borrower on account of such  
29 suit (or the threat of such suit) shall constitute TM Collateral.

30 (c) Following the occurrence of any Event of Default, the Administrative Agent, by  
31 notice to the Borrower may be terminate or limit the Borrower's rights under this Section 6.

32  
33 **7. ADMINISTRATIVE AGENT'S ACTIONS TO PROTECT MARKS:** In the event of

34 (a) the Borrower's failure, within Five (5) days of written notice from the  
35 Administrative Agent, to cure any failure by the Borrower to perform any of the Borrower's  
36 obligations set forth in Section 3; and/or

1 (b) the occurrence of any Event of Default,  
2 the Collateral Agent, acting in its own name or in that of the Borrower, may (but shall not be required to)  
3 act in the Borrower's place and stead and/or in the Collateral Agents' own right in connection therewith.  
4

5 8. **RIGHTS UPON DEFAULT:** Upon the occurrence of any Event of Default, the Collateral  
6 Agent may exercise all rights and remedies of a secured party upon default under the Uniform  
7 Commercial Code as adopted in Massachusetts (Massachusetts General Laws, Chapter 106), with  
8 respect to the Marks, in addition to which the Collateral Agent may sell, license, assign, transfer, or other-  
9 wise dispose of the Marks. Any person may conclusively rely upon an affidavit of an officer of the  
10 Collateral Agent that an Event of Default has occurred and that the Collateral Agent is authorized to  
11 exercise such rights and remedies.  
12

13 9. **ADMINISTRATIVE AGENT AS ATTORNEY IN FACT:**

14 (a) The Borrower hereby irrevocably constitutes and designates the Collateral Agent  
15 as and for the Borrower's attorney in fact, effective following the occurrence of any Event of Default:

16 (i) To exercise any of the rights and powers referenced in Sections 3 and  
17 5(b).

18 (ii) To execute all such instruments, documents, and papers as the  
19 Collateral Agent determines to be appropriate in connection with the exercise of such rights and  
20 remedies and to cause the sale, license, assignment, transfer, or other disposition of the Marks.

21 (b) The within grant of a power of attorney, being coupled with an interest, shall be  
22 irrevocable until this Agreement is terminated by a duly authorized officer of the Collateral Agent.

23 (c) The Collateral Agent shall not be obligated to do any of the acts or to exercise  
24 any of the powers authorized by Section 9 (a) herein, but if the Collateral Agent elects to do any such act  
25 or to exercise any of such powers, it shall not be accountable for more than it actually receives as a result  
26 of such exercise of power, and shall not be responsible to the Borrower for any act or omission to act  
27 except for any act or omission to act as to which there is a final determination made in a judicial  
28 proceeding (in which proceeding the Administrative Agent has had an opportunity to be heard) which  
29 determination includes a specific finding that the subject act or omission to act had been grossly negligent  
30 or in actual bad faith.  
31

32 10. **ADMINISTRATIVE AGENT'S RIGHTS:**

33 (a) Any use by the Collateral Agent of the Marks, as authorized hereunder in  
34 connection with the exercise of the Collateral Agent' rights and remedies under this Agreement and under  
35 the Loan Agreement shall be coextensive with the Borrower's rights thereunder and with respect thereto  
36 and without any liability for royalties or other related charges.

(b) None of this Agreement, the Loan Agreement, or any act, omission, or circumstance taken or arising hereunder may be construed as directly or indirectly conveying to the Collateral Agent any rights in and to the Marks, which rights are effective except following the occurrence of any Event of Default.

11. **INTENT:** It is intended that this Agreement supplement the Loan Agreement. All provisions of the Loan Agreement shall apply to the Marks. The Collateral Agent shall have the same rights, remedies, powers, privileges and discretions, with respect to the security interests created in the TM Collateral as in all other Collateral. In the event of a conflict between this Agreement and the Loan Agreement, the terms of this Agreement shall control with respect to the TM Collateral and the Loan Agreement with respect to all other Collateral.

12. **CHOICE OF LAWS:** It is intended that this Agreement take effect as a sealed instrument and that all rights and obligations hereunder, including matters of construction, validity, and performance, shall be governed by the laws of The Commonwealth of Massachusetts.

IN WITNESS WHEREOF, the Borrower and the Administrative Agent respectively have caused this Agreement to be executed by their respective duly authorized officers as of the date first above written.
