INTELLECTUAL PROPERTY TRANSFER AND ASSIGNMENT

INTELLECTUAL PROPERTY TRANSFER AND ASSIGNMENT dated as of June 19, 2001, by and among EINSTEIN/NOAH BAGEL CORP., a Delaware corporation, and EINSTEIN/NOAH BAGEL PARTNERS, L.P., a Delaware limited partnership (collectively, the "**Sellers**"), and EINSTEIN ACQUISITION CORP., a Delaware corporation (the "**Buyer**").

WITNESSETH:

WHEREAS, the Sellers and the Buyer are parties to an Asset Purchase Agreement, dated as of June 1, 2001 (as amended from time to time in accordance with its terms, the "**Asset Purchase Agreement**"), providing for, among other things, the sale, assignment, transfer and delivery to the Buyer of the Purchased Assets and the assumption by the Buyer of the Assumed Total Liabilities, in each case, as more fully described in the Asset Purchase Agreement and upon the terms and conditions set forth therein.

WHEREAS, concurrently herewith, the Sellers have executed a Bill of Sale (the "**Bill of Sale**"), dated as of the date hereof, pursuant to which the Sellers have vested in the Buyer all of their respective right, title and interest in and to the Purchased Assets described therein.

WHEREAS, the parties now desire to carry out the intent and purpose of the Asset Purchase Agreement by the Sellers' execution and delivery to the Buyer of this instrument evidencing the Sellers' transfer and assignment to Buyer exclusively throughout the world of all of Sellers' respective right, title, interest and licenses, choate or inchoate, in and to all trademarks, trade names, service marks, copyrights, patents, trade secrets, inventions, software and works of authorship (collectively, the "Intellectual Property"), it being agreed that the Intellectual Property hereby transferred and assigned to Buyer includes without limitation:

- (a) The trademarks listed on the attached Schedule A, and all other trademarks owned by Sellers respectively, together with all appurtenant goodwill, applications, inventory, advertising and promotional materials, labels and signage, wherever located;
- (b) The patents listed on the attached Schedule B and any and all other patents or inventions owned by Sellers respectively, and all precursors and works in progress with respect thereto, mask works, technology, information, know how, materials and tools relating thereto, or relating to the development, maintenance or support thereof;
- (c) The trade secrets listed on the attached Schedule C and any and all other formulae, recipes, data compilations, customer lists and information databases, irrespective of the form, mode or character thereof, and without regard to the medium in which located or stored;

- (d) All computer software, source code, object code and machine language used to operate, drive, launch, power, maintain or support any facility or system owned by Sellers, or any Web site, Internet site or Internet-based program or project;
- (e) All books, manuals, instructions, brochures, catalogues, promotional materials, advertising copy and written material of any kind, irrespective of the form, mode or character thereof, and without regard to the medium in which located or stored, and irrespective of whether any copyright application has been filed therefor or is held therein;
- (f) The Domain Names listed on the attached Schedule D and any and all other Uniform Resource Locators (U.R.L.'s) and Domain Names registered by or to Sellers or used to identify any Web site, Internet site or Internet-based program or project;
- (g) All intellectual property rights, applications, industrial property rights of any sort, and all business, contract rights, causes of action and goodwill in, incorporated or embodied in, used to develop or related to any of the foregoing.

WHEREAS, capitalized terms used and not defined herein shall have the meanings ascribed to them in the Asset Purchase Agreement.

NOW, THEREFORE, in consideration of the execution of the Bill of Sale, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Sellers and the Buyer agrees as follows:

1. Transfer and Assignment. Sellers hereby sell, transfer and assign to Buyer all of Sellers' respective right, title, license and interest in and to the Intellectual Property, as defined above in this Intellectual Property Transfer and Assignment.

2. Further Assurances; Moral Rights; Competition; Marketing.

- (a) Sellers agree to assist Buyer in every legal way in Buyer's efforts to evidence, record, perfect and if and whenever necessary reinstate rights in the Intellectual Property, erase and extinguish records of liens and encumbrances, and to apply for and obtain recordation of and from time to time enforce, maintain, and defend the rights acquired by Buyer hereunder, domestically and in foreign countries. Notwithstanding anything contained herein, Buyer and Sellers agree that Buyer shall be responsible for and pay any and all costs, fees and expenses relating to all actions with respect to the Intellectual Property after the Closing, including, but not limited to, filings and recordations, enforcement, maintenance and defense of the Intellectual Property. If the Buyer is unable in

good faith to secure the Sellers' signature to any document it is entitled to under this Section 2(a), Sellers hereby irrevocably designate and appoint the Buyer and its duly authorized officers and agents, as Sellers' agents and attorneys-in-fact with full power of substitution to act for and on behalf and instead of Sellers, to execute and file any such document or documents, and to do all other lawfully permitted acts to further the purposes of the foregoing, with the same legal force and effect as if executed by Sellers, domestically and abroad.

- (b) To the maximum extent permitted by law, the transfer and assignment set forth in Section 1 above includes, without limitation, all rights of paternity, integrity, disclosure and withdrawal and any other rights that may be known as or referred to as "moral rights," "artist's rights," "droit moral" or the like (collectively "Moral Rights"). To the extent Sellers retain any such Moral Rights under applicable law, Sellers hereby ratify and consent to, and shall provide all necessary ratifications and consents to, any actions taken with respect to such Moral Rights by or authorized by Buyer, and Sellers agree not to assert any Moral Rights with respect thereto. Sellers will confirm any such ratifications, consents and agreements from time to time as requested by Buyer.
- (c) Sellers and Buyer agree and acknowledge that solely to record the transfer of ownership hereby effected, documents may be prepared and executed by Buyer or Sellers regarding the transfer of one or more individual trademarks, patents or works, foreign or domestic, making up the Intellectual Property (each such document, an "Individual Transfer Record"). The absence of such additional documentation for any individual trademark, patent or work does not and will not impair the sale, transfer and assignment of same from Sellers to Buyer under this Intellectual Property Transfer and Assignment, which sale, transfer and assignment is hereby acknowledged and completed. Paragraph 1 of this instrument shall be deemed effective as to trademarks named and identified in an Individual Transfer Record, if and only if such Individual Transfer Record is invalid or ineffective.
- (d) Sellers represent and warrant to the Buyer that the Sellers: (i) are the sole owners of all rights, title and interest in the Intellectual Property; (ii) have not assigned, transferred, licensed, pledged or otherwise encumbered the Intellectual Property, nor have Sellers agreed to do so; (iii) transfer the Intellectual Property free and clear of all liens, claims and encumbrances of any kind; (iv) have full right, power and authority to enter into this Agreement and to

perform their obligations as provided for hereunder; (v) are not aware of any violation, infringement or misappropriation of any third party's rights (or any claim thereof) concerning the Intellectual Property; and (vi) are not aware of any questions or challenges with respect to the registrability, patentability or validity of any claims of any existing patents, trademarks, trademark applications, copyright applications or patent applications relating to the Intellectual Property.

3. Transfer of Other Rights. Sellers also transfer to Buyer all intellectual property rights and accommodations that Sellers own, hold or enjoy, which rights and accommodations arise from or exist by reason of Sellers' ownership and control of the issued and outstanding capital stock of Einstein/Noah Bagel Partners, Inc., that California corporation named in and party to the Asset Purchase Agreement. Notwithstanding anything contained herein, Sellers shall have no obligations, and make no representations or warranties, with respect to the rights transferred by this Section 3 other than the obligation to transfer such rights to Buyer.

4. Modification. Nothing contained herein shall release the Sellers or the Buyer from any of their respective duties or obligations under the Asset Purchase Agreement or in any way diminish, limit or modify any of the representations, warranties, indemnities, covenants or agreements of such parties set forth in the Asset Purchase Agreement.

5. Governing Law. This Intellectual Property Transfer and Assignment shall be governed by and construed in accordance with the laws of the State of New York applicable to agreements made and to be performed entirely within such State, without regard to choice of law doctrines.

6. Successors and Assigns. This instrument shall inure to the benefit of, and be binding upon, the Sellers and the Buyer, their respective successors, assigns and legal representatives, for the uses and purposes set forth and referred to herein.

7. Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same original.

8. Amendments. No amendment or modification of this Agreement shall be effective unless it is set forth in writing and signed by each of the parties hereto.

IN WITNESS WHEREOF, the Buyer and the Sellers have executed and delivered this Intellectual Property Transfer and Assignment as of the date first above written.
