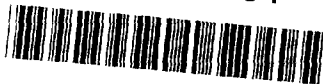

RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This Release of Security Interest in Trademark Collateral ("Release"), entered into as of June 11, 2001 is made by Union Bank of California, N.A. ("Bank").

WITNESSETH:

WHEREAS, Network Music, LLC, a Delaware limited liability company ("Pledgor") and Bank entered into a Loan Agreement dated July 10, 1998 (the "Loan Agreement") pursuant to which Bank made certain loans to Pledgor; and

WHEREAS, to secure repayment of the Obligations (as defined in the Loan Agreement), and Pledgor executed and delivered to Bank a Trademark Security Agreement dated as of July 10, 1998 (the "Trademark Security Agreement") granting a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement), including without limitation the trademarks listed on Attachment A; and

WHEREAS a copy of the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 20, 1998, and a copy of such recordation appears at Reel No. 1757, Frame No. 0256; and

WHEREAS, concurrently herewith the Pledgor is repaying the Loan (as defined in the Loan Agreement); and

WHEREAS, Bank desires to release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged,

1. Release. Bank hereby agrees that the Trademark Security Agreement is hereby terminated, and Bank's security interest in the Trademark Collateral is hereby terminated and released, and neither Pledgor nor Bank shall have any further obligations pursuant to the Trademark Security Agreement. Bank hereby confirms its release of the security interest in, and reassigns, transfers and conveys to Pledgor, any and all right, title and interest which Bank has in or to the Trademark Collateral, including without limitation, the trademarks listed on Attachment A hereto. Bank hereby agrees that it will execute all such further documents as may be requested by Pledgor to carry out the transactions contemplated hereunder.

2. Miscellaneous.

(a) Applicable Law. This Release, and all of the rights and liabilities hereunder, shall be construed in all respects in accordance with, and governed by, all of the provisions of the California Uniform Commercial Code and by the other internal laws (as opposed to conflicts of law provisions) of the State of California.
