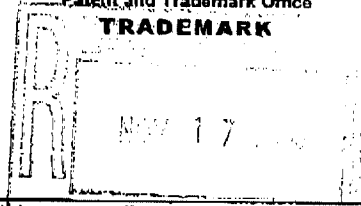

**RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS**

WHEREAS, BELAE BRANDS, INC., a Delaware corporation ("BBI"), having an address at 15458-A North 28th Avenue, Phoenix, Arizona 85053, executed in favor of TSUMURA INTERNATIONAL INC., a Delaware corporation ("TII"), having an address at 300 Lighting Way, Secaucus, New Jersey 07096, that certain Trademark Security Agreement dated December 23, 1998, and that certain Grant of Security Interest in U.S. Trademark Registrations and Applications By Belae Brands, Inc. To Tsumura International Inc. dated December 23, 1998 ("U.S. Grant of Security Interest"), pursuant to which BBI assigned and granted to TII a security interest in and to all of BBI's right, title and interest in and to certain trademarks and to the registrations and applications therefor in the United States and throughout the world, including but not limited to those trademarks specifically listed on Schedule A attached hereto (the trademarks, registrations and applications are hereinafter collectively referred to as "Secured Property"); and

WHEREAS, TII has assigned to MINNETONKA FRAGRANCE INC. , a Delaware corporation ("MFI"), having an address at 910 Sylvan Avenue, Englewood Cliffs, New Jersey 07632, all of TII's right, title and interest in and to the Secured Property pursuant to that certain Assignment dated March 10, 1999 (the "Assignment"); and

WHEREAS, such Assignment was recorded at the Assignment Branch of the U.S. Patent and Trademark Office at Reel 1868, Frame 0008 on March 11, 1999; and

WHEREAS, MFI desires, pursuant to that certain Termination of Trademark Security Agreement between BBI and MFI of even date herewith, to formally release its security interest in and to the Secured Property and in and to any and all other trademarks of BBI and the

goodwill associated therewith, and to record such release with the U.S. Patent and Trademark Office;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, MFI does hereby release and reconvey to BBI all of MFI's right, title and interest in, to and under the Secured Property and in and to any and all other trademarks of BBI.
