(U.S.A.), INC.**, a New York corporation ("Mitsui") (each of the foregoing a "Lender" and collectively, the "Lenders"); **FLEET PRECIOUS METALS INC.**, a Rhode Island corporation (the "Agent") as agent for each of the Lenders in accordance with the terms of an Amended and Restated Intercreditor Agreement dated as of February 25, 1994, as the same may have been amended and/or amended and restated from time to time; and **JERRY MADISON JEWELRY, INC.**, a California corporation (the "Company").

3. The Lenders, the Agent and the Company hereto hereby acknowledge and agree that, as of the date hereof, the Assignment is terminated and shall be of no further force or effect.

4. This Release may be executed in any number of counterparts and by the different parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all of which shall together constitute one and the same instrument.
