**NOTICE OF RELEASE OF  
SECURITY INTEREST IN UNITED STATES TRADEMARKS**

WHEREAS, by a Trademark Security Interest Agreement dated as of April 14, 1999, recorded in the United States Patent and Trademark Office on May 12, 1999 at Reel 1895, Frame 128, BOUNDLESS TECHNOLOGIES, INC., Delaware corporation (“Assignor”) assigned to the Agent (as defined in the Credit Agreement referenced below), a lien upon and security interest in all of the rights, title and interest of the Assignor in and to the trademarks and trademark applications listed on Schedule A (the “Trademarks”); and

WHEREAS, the Assignor, The Chase Manhattan Bank, Silicon Valley Bank and National Bank of Canada (collectively, the “Banks”), The Chase Manhattan Bank, as agent for the Banks (in such capacity, the “Agent”) and certain other Persons are parties to a Second Amended and Restated Credit Agreement, dated as of May 25, 2000 (the “Credit Agreement”);

WHEREAS, the Agent on behalf of the Banks wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Trademarks;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Agent on behalf of the Banks hereby relinquishes, releases and discharges the security interest of the Agent in the Trademarks.
