WHEREAS, on September 13, 1991, The New Albany Company, a general partnership formed under the laws of the State of Ohio and then having an address at 5906 East Dublin-Granville Road, New Albany, Ohio 43054 (the "Assignor"), filed an application, Serial No. 74203218 (the "Application"), with the United States Patent and Trademark Office, to register the service mark NEW ALBANY and Design as indicated in the Application (the "Mark"); and

WHEREAS, on December 1, 1992, the general partners of the Assignor, being Rocky Fork Development Corporation and Community Projects, Inc., both Ohio corporations, together with N.A. Property, Inc., a Delaware corporation, entered into an agreement pursuant to which, among other things, the Assignor was reorganized from a general partnership under the laws of the State of Ohio into a limited partnership organized under the laws of the State of Delaware and continued to conduct its business as a Delaware limited partnership under the name The New Albany Company Limited Partnership (the "Assignee"), with Community Projects, Inc. and N.A. Property, Inc. serving as the general partners thereof; and


WHEREAS, on March 29, 1994, the United States Patent and Trademark Office issued Registration No. 1,828,539 for the Mark in the name of the Assignor; and



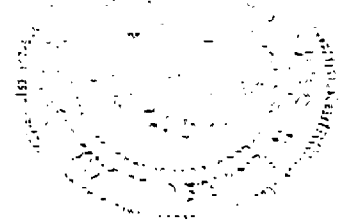
