**DISCHARGE OF RECORDED SECURITY INTEREST**

WHEREAS, by a Security Agreement dated June 3, 1999 (the "Security Agreement"), Gerry Sportswear Company LLC ("Gerry") granted a security interest in Trademark Application No. 75-599,163 to KeyBank National Association (the "Secured Party"), in order to secure repayment of certain amounts then owing to the Secured Party; and

WHEREAS, Trademark Application No. 75-599,163 was subsequently granted Reg. No. 2,370,217 by the United States Patent and Trademark Office (the "PTO") (hereinafter jointly referred to as the "Registration"); and
