RELEASE OF COLLATERAL ASSIGNMENT OF TRADEMARKS

BE IT KNOWN THAT:

WHEREAS, to secure payment of its obligations under that certain Credit Agreement by and between AMERICAN CONSOLIDATED MEDIA, INC., a Delaware corporation ("ACM"), CONSOLIDATED SOUTHWEST MEDIA, INC., a Delaware corporation ("CSM" and together with ACM, the "Borrowers"), and other parties thereto approved by the Banks, in their sole discretion, to be borrowers thereunder, the banks which were signatories thereto (individually, a "Bank" and, collectively, the "Banks") and U.S. BANK NATIONAL ASSOCIATION, a national banking association, one of the Banks, as agent for the Banks ("Agent"), dated as of January 31, 2000, as amended by that First Amendment to Credit Agreement dated as of March 31, 2000, and by that Second Amendment to Credit Agreement dated as of April 6, 2001 (as amended, the "Credit Agreement"), BROWNWOOD NEWSPAPERS, INC., a Texas corporation (the "Assignor"), a wholly-owned subsidiary of a Borrower pledged to the Agent certain assets including the trademarks, trademark applications and trademark registrations set forth on Exhibit A hereto (the "Trademarks") under that certain Collateral Assignment of Trademarks (the "Collateral Assignment") by and between Assignor, and the Agent dated as of January 31, 2000, and recorded in the United States Patent and Trademark Office on February 28, 2000 in Reel/Frame: 002043/0343.

WHEREAS, the Borrower's "Obligations" (as defined in the Credit Agreement) have been fully paid and discharged.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent, on behalf of itself and the Banks, does hereby release, satisfy, terminate and discharge the pledge to the Agent of, and its security interest in, the Trademarks as pledged under the Collateral Assignment, together with that part of the goodwill of the business connected with the use of and symbolized by the Trademarks, and any registrations that may issue in connection therewith.
