

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Sola does hereby sell, assign, transfer and set over to AO Lens, its successors and assigns, all of Sola's right, title and interest in and to the Mark, including United States Registration No. 860,224, together with the goodwill associated with said Mark (including, without limitation, all proceeds thereof and the rights to sue for past, present and future infringements), the same to be held and enjoyed by AO Lens, for its own use and on behalf of its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Sola, had this sale and assignment not been made.

Sola hereby requests the Commissioner of Patents and Trademarks to record AO Lens as the owner of the entire right, title and interest in and to the Mark, including United States Registration No. 860,224, for the sole use and enjoyment of AO Lens, its successors and assigns, and hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.


