TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made as of the 31th day of March, 2001 by Avaya Inc., a Delaware Corporation, having a place of business at 211 Mount Airy Road, Basking Ridge, New Jersey 07920 (hereinafter referred to as "Assignor") to Group ViewStar, Inc., a Delaware corporation, having its principal place of business at 2911 Turtle Creek Blvd., Suite 1100, Dallas, Texas 75219, hereinafter referred to as "Assignee").

WHEREAS, Assignor and Assignee are parties to that certain Purchase and Sale Agreement, dated as of March 31, 2001, by and among Assignor, as seller, Assignee, as buyer, and eiStream, Inc., a Delaware corporation, as guarantor (the "Purchase Agreement").

WHEREAS, the Assignor is desirous of transferring and assigning to Assignee, and Assignee is desirous of acquiring from Assignor all of Assignor's rights, title and interest in and to the Assigned Marks set forth in Schedule A attached hereto and all of the goodwill associated therewith.

together with the goodwill of the business appertaining thereto and which is symbolized by the Assigned Marks and the worldwide right to sue for past infringements of the Assigned Marks.

2. Assignor shall execute any and all documents reasonably requested by Assignee to effect transfer and recording of the Assigned Marks to Assignee.
