**COLLATERAL ASSIGNMENT OF SECURITY INTEREST  
IN TRADEMARKS AND PATENTS**

THIS COLLATERAL ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS AND PATENTS (the "Collateral Assignment") is made as of August 20, 2001 by MULTILINK INC., an Ohio corporation having offices at 580 Ternes Avenue, Elyria, Ohio 44035 ("Assignor") to CHARTER ONE BANK, F.S.B., a federal savings bank having offices at 1215 Superior Avenue, Cleveland, Ohio 44114 ("Assignee").

**WITNESSETH:**

WHEREAS, Assignor is the owner of or has rights to or in certain trademarks, patents and related applications listed on Exhibit A attached to this Collateral Assignment; and

WHEREAS, Assignor and Assignee have entered into that certain Credit Facility and Security Agreement dated as of August 20, 2001 (as from time to time amended, modified or supplemented, the "Credit Agreement"), pursuant to which, upon the satisfaction by the Assignor of the terms and conditions contained therein, Assignee will extend credit to or for the account of Assignor; and

WHEREAS, pursuant to the Credit Agreement, Assignor has agreed to grant Assignee a security interest in all of its right, title and interest in and to the trademarks, patents and related applications described on Exhibit A and in and to the goodwill symbolized by such trademarks, patents and related applications (the "Goodwill"), as collateral security for the obligations of Assignor under the Credit Agreement (the "Obligations"); and

WHEREAS, Assignor is the owner of the entire right, title and interest in the trademarks, patents and related applications which are the subject hereof.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, Assignor hereby:



