RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of August 6, 2001, by FINOVA CAPITAL CORPORATION ("FINOVA"), the secured party under that certain Security Agreement referred to below.

WITNESSETH:

WHEREAS, Quantic Industries, Inc., a Delaware corporation ("Borrower"), executed that certain GRANT OF SECURITY INTEREST TRADEMARKS (the "Security Agreement") dated as of October 1, 1998 pursuant to which Borrower granted a security interest to FINOVA in certain trademarks of Borrower; and

WHEREAS, said Security Agreement was recorded with the Assignment Branch of the United States Patent and Trademark Office on October 9, 1998 at Reel 1799, Frame 0018; and

WHEREAS, FINOVA has agreed to release all its rights under such Security Agreement, including, without limitation, in the trademarks therefor identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to Borrower.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, FINOVA hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of FINOVA'S right, title and interest in and to the Released Collateral, releases all other rights it may have under said Security Agreement with respect to the Released Collateral and cancels such Security Agreement in its entirety, all without warranty or representation of any kind.
