ASSET PURCHASE AGREEMENT

THIS IS AN ASSET PURCHASE AGREEMENT (the "Agreement") dated as of March 9, 1993, as amended and restated on March 31, 1993, by and between DANA CORPORATION, a Virginia corporation ("Seller") and T. B. WOOD'S SONS COMPANY, a Pennsylvania corporation ("Purchaser").

Background

Seller, directly and through its wholly-owned subsidiaries, is the owner of two manufacturing facilities which are located in San Marcos, Texas and Mt. Pleasant, Michigan, respectively. Each of the Mt. Pleasant and San Marcos facilities, together with the assets and properties of Seller located at or, as herein provided, deemed to be associated with each facility, are hereinafter collectively referred to as the "Facilities." The Facilities are used by Seller to engage in the business of developing, engineering, marketing, selling, and supporting the products listed on Annexes I and II to Schedule 7.6 hereto (the "Business"). Purchaser desires to purchase substantially all of the assets and properties of the Business (including the Facilities), and Seller desires to sell such assets and properties, on the terms and subject to the conditions set forth in this Agreement.

Terms

NOW, THEREFORE, in consideration of the mutual covenants contained herein and intending to be legally bound hereby, the parties hereto agree as follows:

ARTICLE 1

DEFINITIONS

1.1 Certain Definitions. As used in this Agreement, the following terms shall have the respective meanings ascribed to them in this Section in each case:

1.1.1 "Acquired Assets" means all of Seller's and its Affiliates' right, title, and interest in, under and to all of the assets, properties and rights constituting, or primarily used in, the Business as a going concern of every kind, nature and description existing on the Closing Date other than the Excluded Assets, wherever such assets are located and whether such assets are real, personal or mixed, tangible or intangible, and whether or not any of such assets have any value for accounting purposes or are carried or reflected on or specifically referred to in Seller's books or financial statements, including all of the assets, properties and rights of the Business enumerated below:
