## TRADEMARK RELEASE OF SECURITY INTEREST

This instrument is executed effective as of the 28<sup>th</sup> day of September, 2001 by The Chase Manhattan Bank (successor by merger to Chase Bank of Texas, National Association, formerly known as Texas Commerce Bank National Association), a New York banking corporation ("Chase"), not in its individual capacity but solely as agent for the Banks specified in the Security Agreement (hereinafter defined) (Chase in such capacity, the "Agent"), 2200 Ross Avenue, 3<sup>rd</sup> Floor, Dallas, Texas 75201.

WHEREAS, CellStar, Ltd., a Texas limited partnership (the "Grantor"), having an address at 1730 Briercroft, Carrollton, Texas 75006, and the Agent executed a Security Interest Assignment of Trademarks dated as of October 15, 1997 ("Security Agreement"), under which Security Agreement the Grantor granted to the Agent a security interest in all of the Grantor's right, title and interest in and to the trademark registrations (collectively, "Trademarks") listed in Exhibit A hereto, to secure payment and performance in full of certain Obligations of the Grantor under a credit agreement among Grantor, Agent and others (the "Credit Agreement").

WHEREAS, the Agent recorded the Security Agreement with the United States Patent and Trademark Office, Assignment Branch, on November 26, 1997, which Security Agreement was recorded at Reel 1659, Frame 0200; and


WHEREAS, the Agent desires to terminate and release its security interest in the Trademarks.

NOW, THEREFORE, in consideration of the satisfaction of all Obligations of the Grantor under the Credit Agreement, the Agent by these presents does hereby release the

security interest in all trademarks, service marks and trademark and service mark registrations and applications, both foreign and domestic, at any time owned by Grantor, including without limitation the Trademarks described on Exhibit A hereto, and the goodwill represented thereby, and including without limitation all renewals thereof, all proceeds thereof (including, but not limited to, all license royalties and proceeds of infringement suits), and the right to sue for past, present and future infringements.

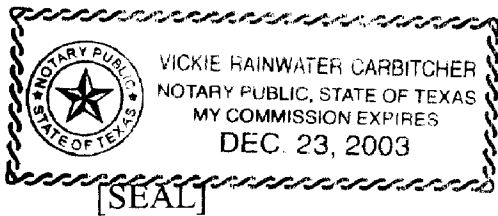
