1. They constitute a majority of the directors now in office of Humidial Corporation, a California corporation (the "Corporation").
2. The Corporation has been completely wound up.
3. The Corporation's known debts and liabilities have been adequately provided for by the assumption thereof by the parent and sole shareholder of the Corporation, United Catalysts Inc., a Delaware corporation ("UCI"), 1600 West Hill Street, P.O. Box 32370, Louisville, Kentucky 40232.
4. The known assets of the Corporation have been distributed to the person entitled thereto.
5. UCI will assume the tax liability, if any, of the dissolving corporation as security for the issuance of a tax clearance certificate from the Franchise Tax Board and is responsible for additional corporate taxes, if any, that are assessed and that become due after the date of the assumption of the tax liability.
6. The election to dissolve was made by the affirmative vote of UCI, the sole shareholder of the Corporation and holder of all of the outstanding shares thereof.
7. The Corporation is dissolved on December 31, 1998.

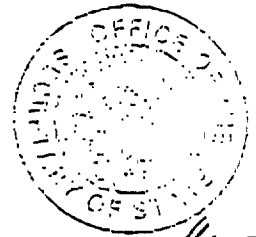
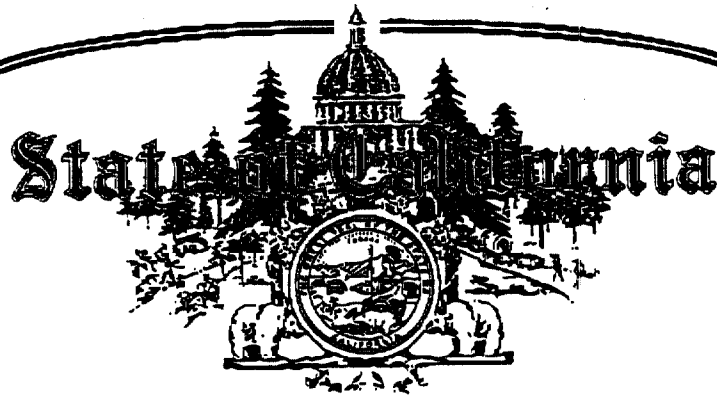

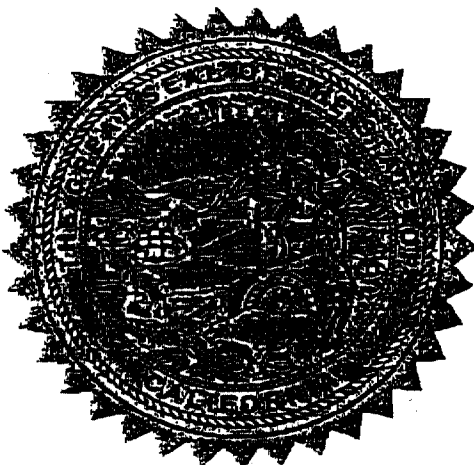
