SECURITY INTEREST
IN UNITED STATES TRADEMARKS, PATENTS, AND COPYRIGHTS**

**THIS NOTICE OF SECURITY INTEREST IN UNITED STATES
TRADEMARKS, PATENTS, AND COPYRIGHTS (“Notice of Security Interest”),** dated as of November 28, 2001, is made by Compass Minerals Group, Inc., and each other Subsidiary of Salt Holdings Corporation identified in the USC&GA (as defined below) (collectively the “Grantors”) in favor of JPMorgan Chase Bank, as Collateral Agent.

Reference is made to the the Credit Agreement dated as of the date hereof (the “Credit Agreement”) among Salt Holdings Corporation, Compass Minerals Group, Inc., Sifto Canada, Inc., Salt Union Limited, the Lenders party to the Credit Agreement, JPMorgan Chase Bank as Administrative Agent, J.P. Morgan Bank Canada as Canadian Agent, Chase Manhattan International Limited as UK Agent, Deutsche Banc Alex. Brown Inc. as Syndication Agent, Joint Advisor, Co-Lead Arranger and Joint Bookrunner, Credit Suisse First Boston as Co-Documentation Agent and Credit Lyonnais as Co-Documentation Agent. Capitalized terms not otherwise defined herein are defined as in the USC&GA.

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein; and

WHEREAS, in connection with the Credit Agreement, Salt Holdings Corporation, the US Borrowers and certain of its Subsidiaries have executed and delivered a United States Collateral and Guarantee Agreement dated as of November 28, 2001 in favor of the Collateral Agent, (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “USC&GA”);

WHEREAS, pursuant to the USC&GA, the Grantors pledged and granted to the Collateral Agent and its successors and assigns, for the ratable benefit of the Secured Parties a security interest in, inter alia, all General Intangibles, including Trademarks, Patents, and Copyrights; and

WHEREAS, Grantors have duly authorized the execution, delivery and performance of this Notice of Security Interest;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to make Loans and other financial accommodations to the US Borrower pursuant to the Credit Agreement, the Grantors agree, for the benefit of the Collateral Agent and the Secured Parties, as follows:

SECTION 1. Grant of Security Interest. The Grantors hereby pledge and grant a security interest in, effective upon demand made upon the occurrence and during the continuance of an Event of Default, the Trademarks, Patents, and Copyrights (including, without limitation, those items listed on Schedule I hereto), to the Collateral Agent for the benefit of the Secured Parties to secure payment, performance and observance of the Obligations.

SECTION 2. Purpose. This Notice of Security Interest has been executed and delivered by the Grantors for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office and the United States Copyright Office. The security interest granted hereby has been granted to the Collateral Agent and the Secured Parties in connection with the USC&GA and is expressly subject to the terms and conditions thereof. The USC&GA (and all rights and remedies of the Collateral Agent thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 3. Acknowledgment. The parties hereto do hereby further acknowledge and affirm that the rights and remedies of the Secured Parties with respect to the security interest in the Trademarks, Patents, and Copyrights granted hereby are more fully set forth in the USC&GA, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 4. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.


