
TRADEMARK TRANSFER AND ASSIGNMENT

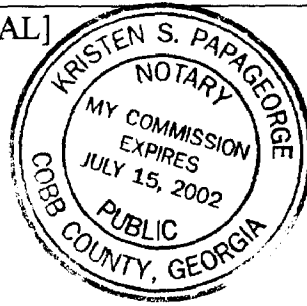
