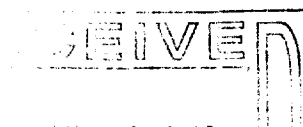

Termination of Trademark Collateral Assignment

This TERMINATION OF TRADEMARK COLLATERAL ASSIGNMENT is executed as of October 23, 2001 by Bank of America, N.A., FKA NationsBank, N.A. (the "Bank") with reference to that certain Loan and Security Agreement dated as of June 29, 1998 between the Bank and Color Tile, L.L.C. (the "Company").

- (c) to the extent the Bank shall be deemed to have any right, title or interest in the Property, retransfers and reassigns to the Company all of such right, title and interest.

This Termination of Trademark Collateral Assignment shall be governed by the laws of the State of Missouri and shall relate solely to the Assignment.

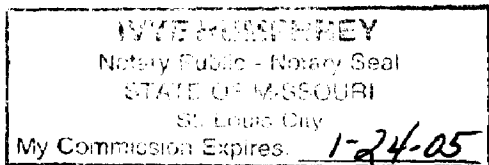
