

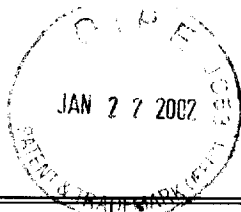

Whereas, Assignor is the owner of the trademarks and registrations for such trademarks identified on Schedule A attached hereto ("Trademarks");


