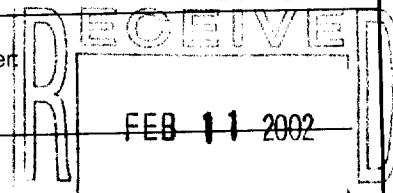

TRADEMARK CONVEYANCE

WHEREAS, WELLS FARGO BUSINESS CREDIT, INC. (formerly known as Norwest Business Credit, Inc.), a corporation of the State of Minnesota having a place of business at 100 East Wisconsin Avenue, Milwaukee, Wisconsin 53202 ("Conveyor"), has the right pursuant to Section 409.610 of the Wisconsin statutes to convey the entire right, title and interest in and to the trademarks listed on attached **Schedule A** (hereinafter the "Trademarks") together with the goodwill of the business symbolized thereby by virtue of the following agreement and events:

A certain Credit and Security Agreement dated December 29, 1995 (the "Agreement"), between Midwest Embroidery, Inc. (now known as Cadre Athletic, Inc.) ("Borrower") and Conveyor, in which Borrower granted Conveyor a security interest in all Borrower's General Intangibles (as that term is defined in the Agreement) including U. S. Trademark Registration No. 2,292,052 for the mark "Cadre Athletic";

Recordation of Conveyor's first priority security interest in various assets of Borrower, including all Borrower's General Intangibles, in accordance with the Uniform Commercial Code;

The occurrence of various defaults pursuant to the Agreement, notice of which was given by Conveyor to Borrower and Borrower's failure to comply with Conveyor's demand, made as of December 20, 2000, for payment in full of Borrower's obligations to Conveyor on or prior to March 20, 2001;

WHEREAS, Next, Inc., a corporation of the State of Delaware having its principal place of business at 6430 Cobble Lane, Harrison, TN 37341 ("Recipient"), desires to acquire Conveyor's entire right, title and interest in and to the Trademarks worldwide, together with the goodwill of the business symbolized thereby;

NOW THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that in consideration of the payment of Recipient to Conveyor of Two Thousand Dollars (\$2,000.00) plus attorney costs and other good and valuable consideration, Conveyor hereby sells, assigns and transfers to Recipient the complete right, title and interest in and to said Trademarks that it is entitled to convey, together with the goodwill associated therewith.
