This Release shall be limited to and solely affect Assignee Guaranteed Obligations Collateral and shall not apply to, affect or impair any right, title or interest of Assignor in, to, and under any other Guaranteed Obligations Collateral of


any Subsidiary Guarantors (as defined in the Subsidiary Security Agreement) other than the Assignees.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases all right, title, and interest in the Assignee Guaranteed Obligations Collateral and reassigns all right, title and interest in the Assignee Guaranteed Obligations Collateral to Assignees and their respective successors and assigns.
