

FIRST: That the Board of Directors of the Corporation, by the unanimous written consent of its members, pursuant to Section 141(f) of the General Corporation Law of the State of Delaware, adopted resolutions setting forth a proposed amendment of the Restated Certificate of Incorporation of the Corporation, declaring said amendment to be advisable and calling upon the sole stockholder of the Corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Restated Certificate of Incorporation of the Corporation be amended by changing Article I thereof so that, as amended, said article shall be and read as follows:
