TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") made this 5th day of September, 1997 by SONOCO PARTITIONS, INC. , a South Carolina corporation ("Sonoco Partitions").

WITNESSETH:

WHEREAS, Sonoco Partitions desires to transfer the Marks (as defined below) to RTS Packaging, LLC, a Delaware limited liability company (the "Company"), as a contribution to the capital of the Company;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Assignment of the Marks. Sonoco Partitions does hereby assign, grant, transfer, contribute and deliver to the Company all of its right, title and interest in, including all goodwill associated therewith, and to any and all of the trademarks listed on Exhibit 1 hereto, and any applications therefor (the "Marks"). All use of the Marks by the Company and all goodwill generated thereby shall be the sole property of the Company and inure to the benefit of the Company.

2. Further Assurances. Subject to the terms and conditions herein provided, each of the parties hereto agrees to take or cause to be taken all action, and to do or cause to be done all things necessary or advisable to consummate and make effective the transfer, assignment and contemplated by this Agreement.

3. Successors and Assigns. The terms and provisions of this Agreement and the respective rights and obligations of the parties hereunder shall be binding upon, and inure to the benefit of, their respective successors and assigns.

4. Recordings. An executed copy of this Agreement may be filed with the U.S. Copyright Office and the U.S. Patent and Trademark Office by Sonoco Partitions or the Company at any time.


