### TERMINATION OF PATENT AND TRADEMARK SECURITY AGREEMENT

This Termination of Patent and Trademark Security Agreement (this "Termination"), dated as of February 22, 2002 is executed by Bank of America, N.A., as Agent (the "Agent"), having its principal offices at 101 N. Tryon Street, NC1-001-08-19, Charlotte, NC 28255, in favor of Curtis 1000, Inc., a Georgia corporation (the "Debtor"), having its principal offices at 8310 S. Valley Highway, #400, Englewood, CO 80112.

#### RECITALS

WHEREAS, Debtor and certain of its affiliates, various lenders, and Agent entered in a certain Credit Agreement, dated as of February 18, 2000 (the "Credit Agreement"); and

WHEREAS, in connection with the Credit Agreement, Debtor and Agent entered into a certain Patent and Trademark Security Agreement dated as of February 18, 2000 (the "Patent and Trademark Security Agreement"); and

WHEREAS, pursuant to the Patent and Trademark Security Agreement, Debtor granted to Agent a security interest in certain "Collateral" including certain trademarks; and

WHEREAS, in connection with the sale of 100% of the capital stock of Debtor, Mail-Well I Corporation, the Debtor's parent company, has requested that the Patent and Trademark Security Agreement be terminated.

NOW, THEREFORE, Agent agrees as follows:

1. Agent is executing and delivering this Termination as further evidence of the termination of the Patent and Trademark Security Agreement.
2. Agent claims no right, title or interest whatsoever in or to any of the "Collateral" described in the Patent and Trademark Security Agreement, and, accordingly, Agent expressly terminates its security interest in the registered trademarks listed on Exhibit A hereto, which security interest was evidenced by the recordation of the Patent and Trademark Security Agreement with the United States Patent and Trademark Office on May 22, 2000 as to trademarks, in Reel/Frame 002086/0676.
