## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** ("Assignment") is made and entered into as of this 22<sup>nd</sup> day of March 2002, ("Effective Date"), by and between Waters Investments Limited a Delaware corporation organized under the laws of the State of Delaware, with its principal office at 109 Lukens Drive, New Castle, Delaware 19720 ("Assignor"), and YMC Co., Ltd., a corporation organized under the laws of Japan, with its principal office at 566 Toroyacho, Karusuma, Oike Saguru, Nakagyo-ku, Kyoto 604, Japan ("Assignee").

**WHEREAS**, Assignor and Assignee have entered into that certain Distribution and Supply Agreement dated July 31, 1997 (the "Distribution Agreement"), pursuant to which Assignor has agreed to assign to Assignee, that United States trademark application for registration identified and set forth on Schedule A (referred to herein as the "Mark") and the goodwill of the Assignor's business associated with the Mark; and **WHEREAS**, Assignee wishes to acquire and Assignor wishes to assign its entire right, title and interest in and to the Mark, together with the goodwill of the business with which the Mark is used;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee, its entire right, title and interest in and to the Mark, together with the goodwill of the business with which the Mark is used, including any renewals and extensions of the registrations that are or may be secured under the laws of the United States now or hereafter in effect, for Assignee's use and enjoyment as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all income, royalties, damages or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims against third parties for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for, and collect the same for Assignee's use and enjoyment.

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner of the Mark in the United States.
