RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Agreement") is made as of the 28th day of December, 2001, between APCOM, Inc., a Tennessee corporation ("Apcom" or "Assignee") and Bank of America, N.A., formerly NationsBank, N.A., as Agent for the benefit of the lenders, a national banking association (the "Assignor" or "Agent").

WHEREAS, Apcom and Assignor entered into a trademark security agreement in connection with certain loan documents recorded with the United States Patent and Trademark Office on or about September 10, 1997 at Reel 1629, Frame 0888, for the purpose of securing certain obligations of Apcom to certain financial institutions;

WHEREAS, pursuant to the trademark agreement, Apcom granted the Agent a continuing security interest in all of its Marks, including without limitation the trademarks identified on Schedule A attached hereto, and pledged and mortgaged (but did not transfer title to) the Marks to the Agent;

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the trademark agreement:

The Agent hereby terminates and releases its security interest in the Marks, including without limitation, the Marks identified on Schedule A attached hereto, and the Assignor hereby assigns and transfers to Apcom, without any representation, warranty or recourse whatsoever, the Assignor's entire right, title and interest in and to the Marks, including without limitation the Marks listed on Schedule A attached hereto, effective as of the date set forth above.
