TO
ARTICLES OF INCORPORATION
OF
COTT BEVERAGES USA, INC.

ARTICLEI

The name of the corporation is COTT BEVERAGES USA, INC. (the "Corporation").

ARTICLE II

The following amendments (the "Amendment") to the Articles of Incorporation of the Corporation has been adopted as follows:

A. The text of Article 1 of the Articles of Incorporation of Cott Beverages USA, Inc. ("Articles") is hereby deleted usits entirety and the following substituted in lieu thereof:

"The name of the corporation is "BCI" A CORP."

P. The text of Article 5 of the Articles is hereby deleted in its entirety and the following is substituted in lieu thereof:

The maximum number of shares of capital stock that the Corporation should be authorized to have outstanding at anytime shall be 1,000,000 shares of voting common capital stock of no par value. The amount of capital with which the Corporation shall begin business shall not be less than \$500. The shares of capital stock are not subject to redemption by the Corporation.

ARTICLEIU

The Amendment was adopted on the 24th day of January, 2000, by the ununimous written consent of the Board of Directors and the sole Shareholder of the Corporation.
