RELEASE OF SECURITY INTEREST OF TRADEMARKS

This Release of Security Interest is dated as of March 27, 2002. Reference is hereby made to the Grant of Trademark Security Interest (the "**Trademark Grant**") by and between Sun Gro Horticulture Canada Ltd., a Canada corporation ("**Grantor**"), and Bankers Trust Company, as Administrative Agent (the "**Administrative Agent**"), recorded with the United States Patent and Trademark Office on or about September 15, 1995 (Reel/Frame No. 1386/0609).


Bankers Trust Company hereby notifies, acknowledges to and agrees with Grantor that the security interest granted by Grantor to Administrative Agent pursuant to the terms of the Trademark Grant including without limitations, the trademarks listed on the attached Schedule A, are terminated and released as of the date hereof, and that Administrative Agent hereby releases and forever discharges all of its right, title and interest of any kind or nature granted, assigned or conveyed pursuant to the Trademark Grant to such Trademark Collateral.

Such Administrative Agent releases all liens, pledges, security interests, charges and other encumbrances of whatever nature (collectively, "**Encumbrances**") on this Release of Security Interest including, without limitation, those Encumbrances created under or in connection with the Trademark Grant.

Such Administrative Agent hereby agrees to take such further actions and to execute such further documents as Grantor may reasonably request to effect and evidence this Release, including, without limitation, the execution of any filings, statements, amendments, recordations or other instruments required to maintain the applications or registrations of the Trademark Collateral and record the chain of title accordingly with the United States Patent and Trademark Office, subject, in each case to the Grantor's prior payment in full to the Administrative Agent of its costs and expenses (including reasonable fees and disbursements of counsel) incurred in connection therewith; provided, however, that Administrative Agent shall not be required to take any action which exposes the Administrative Agent to personal liability or which is contrary to applicable law.

IN WITNESS WHEREOF, Administrative Agent has caused this Release of Security Interest to be duly executed and delivered by its duly authorized officer as of the date first above written.
