TRADEMARKS

THIS GRANT OF SECURITY INTEREST, dated as of June 3, 2002, is executed by SYSTEMS XCELLENCE USA, INC., a Texas corporation ("Debtor"), in favor of GATX CAPITAL CANADA INC. ("Secured Party").

A. Pursuant to a Security Agreement, dated as of June 3, 2002 (the "Agreement") among Debtor and Secured Party, Secured Party has agreed to execute certain waivers and agreements upon the terms and subject to the conditions set forth therein;

C. 
