RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of June 19, 2002, by U.S. Bank National Association, a national banking association and formerly known as Firststar Bank, National Association ("Bank").

WHEREAS, Bank and Cummings Incorporated, The International Sign Service, a Tennessee corporation ("Debtor"), are parties to that certain Trademark Security Agreement dated as of April 28, 1999, which was filed with The United States Patent and Trademark Office on June 4, 1999 in its records at Reel 001907, Frame 0790, as amended by a First Amendment to Trademark Security Agreement dated as of October 24, 2001, which was filed with The United States Patent and Trademark Office on December 3, 2001 in its records at Reel 002403, Frame 0831 (as amended, the "Agreement");

WHEREAS, the Agreement granted, assigned and pledged to Bank a security interest in Debtor's entire right, title and interest in and to all of its "Trademark Collateral" meaning all of its now owned or existing and filed and hereafter acquired or arising and filed: trademarks, service marks, trademarks or service mark registrations, trade names and trademark or service mark applications (exclusive of Intent to Use Applications as defined in the Agreement), including each mark, registration and application listed on Schedule I of the Agreement (attached hereto and made part hereof as Schedule I) and (i) all renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including damages and payment for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, (iv) all rights corresponding thereto throughout the world, (v) the Trademark License Rights as defined in the Agreement, and (vi) together in each case with the goodwill of the Debtor's business connected with the use of, and symbolized by, the Trademark Collateral; and

WHEREAS, Bank desires to release its rights and interests in the Trademark Collateral.

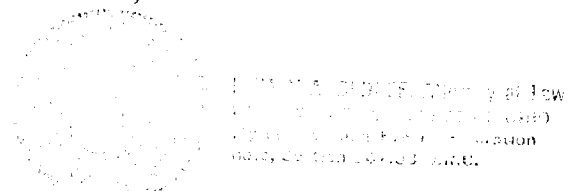
NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademark Collateral and (ii) any and all other rights it may have under the Agreement.

IN WITNESS WHEREOF, Bank has caused this Release of Trademark Security Agreement to be duly executed as of the day and year first above written.


