

BACKGROUND

- A. By an Intellectual Property Security Agreement dated as of June 8, 1998 (the "**Security Agreement**"), **MB Paper Limited**, granted in favour of the undersigned a security interest (the "**Security Interest**") in the collateral described in the Security Agreement.
- B. Through a series of continuations, name changes and amalgamations, MB Paper Limited became a Federally incorporated corporation called Norske Skog Canada Limited (the "**Company**").
- C. Notice of the Security Agreement was filed in various intellectual property offices throughout the world.
- D. The undersigned has agreed to discharge the Security Agreement.
