WHEREAS, the indebtedness secured by the Agreement has been paid in full, and, therefore, termination of the Agreement is in order.



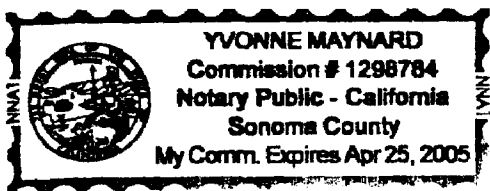
