John J. Nelson and Catherine A. Gessner certify as follows:

1. They are the Officers of St. JON Acquisition Corporation, a California corporation (the "Corporation"), and they hold the offices set forth below their names.

2. In accordance with Sections 902, 905, and 907 of the General Corporation Law of California, the FIRST article of the Articles of Incorporation of the Corporation shall be amended to read as follows:

The name of the Corporation is St. JON Laboratories, Inc. (the "Corporation").


3. The amendment was approved by the Board of Directors and the outstanding shares in accordance with Section 902 of the General Corporation Law of California. The total number of outstanding shares of the Common Shares entitled to vote with respect to the amendment was 1,000 shares, the affirmative vote of a majority of the outstanding Common Shares was required for approval by the outstanding shares, and the amendment was unanimously approved by 100% of the Common Shares entitled to vote.

4. In all other ways, the Articles of Incorporation shall remain unchanged.

IN WITNESS WHEREOF, the undersigned officers of the Corporation have executed this Certificate of Amendment as of December 29, 1995, and we further declare under penalty of perjury the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
