ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS ASSIGNMENT AND ASSUMPTION AGREEMENT ("Assignment") is made as of January 31, 1995 by Barclays Business Credit, Inc., a Connecticut corporation having an office at 2300 North Mayfair Road, Wauwatosa, Wisconsin 53221 ("Assignor") in favor of Shawmut Capital Corporation, a Connecticut corporation having an office at 20800 Swenson Drive, Suite 350, Waukesha, Wisconsin 53186 ("Assignee").

RECITALS

WHEREAS, Wrought Washer Mfg., Inc., a Wisconsin corporation ("Borrower"), and Assignor, as Lender, entered into that certain Loan and Security Agreement dated as of February 6, 1986 (as amended, the "Loan Agreement"); and

WHEREAS, pursuant to the Loan Agreement, Borrower entered into that certain Trademark Mortgage and Security Agreement dated as of February 6, 1986 in favor of Assignor (the "Security Agreement"), and recorded with the United States Patent and Trademark Office on March 17, 1986 at Reel 0520 Frame 414; and

WHEREAS, pursuant to the Security Agreement, Borrower granted, assigned and conveyed to Assignor all right, title and interest in and to the trademarks listed on Exhibit A attached hereto;

WHEREAS, Assignor, Barclays Bank PLC, Shawmut National Corporation and Shawmut Bank Connecticut, N.A. have entered into that certain Purchase and Assumption Agreement dated as of November 12, 1994 (the "Purchase Agreement") pursuant to which Assignor has agreed to execute and deliver this Assignment to Assignee.

NOW, THEREFORE, in consideration of the recitals set forth above, which are made a part of this Assignment, and in consideration of Ten Dollars (\$10), the conditions and covenants contained herein and in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby assigns to Assignee all of Assignor's right, title and interest in, to and under the Security Agreement, and Assignee hereby assumes all of Assignor's obligations thereunder.

2. Nothing herein contained or done pursuant hereto shall affect or be construed to affect the security interests granted by the Security Agreement, or the validity, priority or continued effectiveness of the Loan Agreement, the Security
