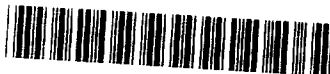

infringement of any of the Marks or unfair competition regarding the same, and granted to Collateral Agent by the Assignor by the Security Agreement, which Assignment was duly recorded on January 15, 2002 at Trademark Reel 002434, Frame 0986 in the United States Patent and Trademark Office.
