RELEASE OF SECOND AMENDED AND RESTATED TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT

This Release of Second Amended and Restated Trademark Collateral Assignment and Security Agreement is made as of October 9, 2000, by FLEET CAPITAL CORPORATION, with an office at One North Franklin, Suite 3600, Chicago, Illinois 60606 ("Lender") relating to JAMESTOWN METAL PRODUCTS, INC., a New York corporation, with its main office and principal place of business at 178 Blackstone Avenue, Jamestown, New York 14701 ("Borrower").

WHEREAS, Borrower and Lender entered into a certain Second Amended and Restated Loan and Security Agreement dated as of January 31, 1999 (the "Loan Agreement"); and
