ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT is made effective this 31st day of May, 1998 by ^{THE} Electronics Boutique, Inc., a Pennsylvania corporation having a principal place of business at 1345 Enterprise Drive, Goshen Corporate Park, West Chester, PA 19380 ("Assignor") to Elbo Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor has adopted and is currently using the trademarks and registrations set forth on Schedule A hereto, which are in use in the United States and the Republic of Korea in connection with mail order and retail store services involving electrical, electronics and computer related products and accessories, (hereinafter the "trademarks") and which are eligible for registration in other countries;
