**NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS, by (i) the Amended and Restated Guarantee and Collateral Agreement (the "Guarantee and Collateral Agreement"), dated as of April 30, 1999, as amended and restated as of October 30, 2001, and as amended and supplemented from time to time, by GenTek, Inc. and certain of its subsidiaries (collectively, the "Company" or the "Obligors") in favor of JPMorgan Chase Bank, formerly known as The Chase Manhattan Bank (the "Agent") and (ii) the Credit Agreement among the Company, Noma Company, the several lenders from time to time a party thereto, the Bank of Nova Scotia (as "Syndication Agent"), Bankers Trust Company (as "Documentation Agent") and the Agent, dated as of April 30, 1999, as amended and restated as of August 9, 2000 and as of August 1, 2001 (the "Credit Agreement" and together with the Guarantee and Collateral Agreement, the "Credit Documents"), the Obligors granted to the Agent a security interest in the Obligors' right, title and interest in, to and under the Collateral (as defined in the Guarantee and Collateral Agreement), including the Obligors' right, title and interest in, to and under the trademarks set for in Schedule 1 annexed hereto, the goodwill associated therewith and the trademark registrations therefor (the "Trademarks").

WHEREAS, the parties desire to provide a document suitable for recording in the PTO for purposes of recording the release, relinquishment and discharge by the Agent of its security interest in the Trademarks;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to the provisions of the Credit Documents, the Agent for itself and on behalf of the Lenders (as defined in the Credit Documents) hereby relinquishes, releases and discharges its and their security interest in the Trademarks, together with the goodwill associated with the Trademarks, created pursuant to the Credit Documents, and any right, title or interest of the Agent and the Lenders in, to and under the Trademarks pursuant to the Credit Documents shall hereby cease and become void.

At any time and from time to time after the date hereof, the Agent shall, at the request and expense of the Obligors, execute and deliver such further documents and perform such further acts as may be necessary in order to effectively release any and all interest of the Agent and the Lenders in the Trademarks.
