

TRADEMARK SECURITY INTEREST RELEASE

This RELEASE is given as of this 19th day of February 2003 by Antares Capital Corporation f/k/a Antares Leveraged Capital Corp., a Delaware corporation ("Assignor"), located at 311 South Wacker Drive - Suite 6400, Chicago Illinois 60606, in favor of SpectaGuard Acquisition LLC, a Delaware limited liability company ("Assignee"), located at 3606 Horizon Drive, King of Prussia, PA 19406.

WHEREAS, pursuant to a Trademark Security Agreement dated as of January 23, 1998 (the "Security Agreement"), by and between Assignee and Assignor, Assignee granted to Assignor a continuing security interest in all of Assignee's right, title and interest in, to and under the Trademark Collateral (as defined in the Security Agreement) including the trademark set forth on Schedule A attached hereto (the "Trademark") which security interest was recorded in the United States Patent and Trademark Office on January 29, 1998 at Reel 1684/Frame 0544; and

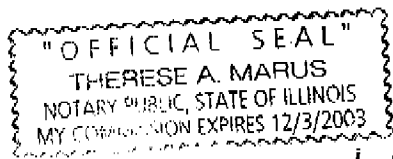
