2. Article 1 of the Articles of Incorporation of the corporation is hereby amended so as henceforth to read as follows:

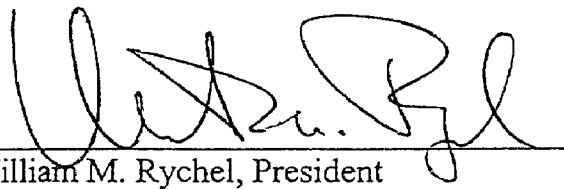
"The name of the corporation is Centiv, Inc."
