ASSIGNMENT OF TRADEMARKS

This Assignment having an effective date of the later date signed below is made by and between SUN COUNTRY AIRLINES, INC., a corporation of the State of Minnesota ("Assignor") and MN AIRLINES, LLC, a Minnesota limited liability company ("Assignee").

WHEREAS, Assignor has adopted and owns certain trademarks listed on Schedule 1 which are registered in the U.S. Patent and Trademark Office or which are the subject of pending applications in the U.S. Patent and Trademark Office (hereinafter the "Marks") and,

WHEREAS, U.S. Bank National Association ("U.S. Bank") has a lien on substantially all of the assets of the Assignor and a perfected security interest in the general intangibles of the Assignor, including the Marks and,

WHEREAS, the Assignor is in default of its obligations to U.S. Bank, and

WHEREAS, U.S. Bank under Article 9 of the Uniform Commercial Code, as in effect in Minnesota, desires to foreclose on certain assets of the Assignor, including its security interest in the Marks, and to simultaneously convey such assets and Marks to the Assignee pursuant to that certain Agreement for Sale of Collateral dated as of March 6, 2002, as amended, and

WHEREAS, U.S. Bank, the Assignor, and the Assignee have agreed to enter into this Assignment of Trademarks to effect the transfer of the Marks to the Assignor in the records of the U.S. Patent and Trademark office.

NOW THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign and transfer unto Assignee, and its successors and assigns, all of its right, title and interest in and to the Marks, and the registrations and applications therefor, together with that part of the good will of the business connected with the use of and symbolized by the Marks, and including Assignor's entire right, title and interest in and to any and all causes of action and rights of recovery for past infringement of the Marks. Assignor hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith. Each Mark is being assigned as part of a transfer of the entire business or portion thereof to which the Marks pertain as required by Section 10 of the Lanham Act.
