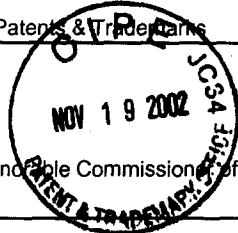

DECLARATION OF RAY CHUNG

RAY CHUNG declares that:

1. On November 7, 1989, I was Executive Vice President of Windmill Corporation, a Delaware corporation, formerly known as Martha White Foods, Inc. ("Martha White"), and was duly authorized to make statements and execute affidavits on its behalf.
2. I was the Executive Vice President of Windmill Corporation, a Delaware corporation ("Old Windmill"), from its inception until the Merger (defined below) on November 7, 1989.
3. On November 7, 1989, Old Windmill acquired all of the outstanding shares of Martha White. Martha White owned all the issued and outstanding stock of its wholly-owned subsidiary, Frozen Specialties, Inc., a Delaware corporation ("Old Frozen Specialties").
4. Old Windmill was merged with and into Martha White, with Martha White surviving such merger (the "Merger"), pursuant to a Certificate of Ownership and Merger filed with the Secretary of State of Delaware on November 7, 1989 (the "Merger Document"). In accordance with the Merger Document, Martha White changed its name to Windmill Corporation.
5. On information and belief, the Merger Document was recorded with the United States Patent & Trademark Office ("PTO") on December 16, 1989, along with a Schedule

thereto of Martha White's patents and trademarks (and applications therefor), on the Trademark Assignment records at Reel 0694, Frames 0061 to 0069, a copy of which is attached hereto as Exhibit A.

6. A page entitled "Frozen Specialties, Inc. - List of Marks" ("Old Frozen Specialties List") inadvertently was attached to the Merger Document when it was submitted to the PTO, and ultimately, incorrectly recorded with the Merger Document at Trademark Reel 0694/Frame 068. The Old Frozen Specialties List reflected trademark registrations owned by Old Frozen Specialties, including Registration No. 676,421 for the trademark *G ★ W* (Stylized).¹ The Merger Document was incorrectly recorded against these registrations, including Registration No. 676,421, as aforesaid.

7. On information and belief, at no time has Windmill Corporation ever been the owner of the trademarks owned by Old Frozen Specialties, including Registration No. 676,421, as listed on the Old Frozen Specialties List recorded at Trademark Reel 0694/Frame 068, recorded with the Merger Document in the PTO.

8. It is respectfully requested that the trademark assignment records of the PTO be amended to correct the error caused by the incorrect recordation of the Old Frozen Specialties List at Trademark Reel 0694/Frame 068.

9. All statements made herein of his own knowledge are true and that all statements made on information and belief are believed to be true; and further, that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States

¹ The Old Frozen Specialties List also included three other trademarks and U.S. registrations therefor: Reg. No. 722,310 for "LAMBRECHT"; Reg. No. 907,259 for "MARIO'S"; and Reg. No. 962,160 for "OUR OWN", all of which have expired.

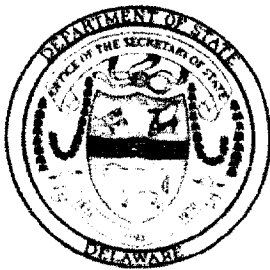

WINDMILL CORPORATION, a corporation organized and existing under the laws of the State of Delaware (the 'Corporation'), DOES HEREBY CERTIFY:

FIRST: That the Corporation was incorporated on October 19, 1989 pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of the stock of Martha White Foods, Inc., a corporation incorporated on March 19, 1986, pursuant to the General Corporation Law of the State of Delaware.

THIRD: That the Corporation, by the following resolutions of its Board of Directors, adopted by unanimous written consent in lieu of a meeting dated November 1, 1989, and of its stockholders, adopted by written consent dated November 1, 1989, determined to and did approve the merger of itself into Martha White Foods, Inc.

RESOLVED, that it is advisable and in the best interests of the Corporation that the Corporation shall be merged with and into the Corporation's wholly-owned subsidiary, Martha White Foods, Inc., a Delaware corporation ("Martha White"), and Martha White shall be the surviving corporation and shall continue to exist as said surviving corporation under the laws of the State of Delaware; and further

RESOLVED, that pursuant to the merger, WC Holding Company Inc., a Delaware corporation ("WC Company"), shall become the sole stockholder of Martha White upon the issuance of stock of Martha White and WC Company's surrender of all stock certificates in the Corporation; and further

RESOLVED, that the merger shall be effective upon the date and at the time a Certificate of Ownership and Merger is filed with the Secretary of State of Delaware (the "Merger"); and further

RESOLVED, that the proper officers of the Corporation be, and they hereby are, directed to make and execute a Certificate of Ownership and Merger (the "Certificate") to be filed in Delaware, setting forth a copy of the resolutions to merge the Corporation into Martha White, and to cause such Certificate to be filed with the Secretary of State of Delaware and a certified copy recorded in the Offices of the Recorders of Deeds of Kent County and New Castle County and to file all such other certificates and to do all acts and things whatsoever, which may be necessary or proper to effect said merger; and further

RESOLVED, that upon the effective date of the merger, the corporate name of Martha White, the surviving corporation, shall be changed and become Windmill Corporation.
