
**SUPPLEMENT TO
SUBSIDIARY PATENT AND TRADEMARK SECURITY AGREEMENT**

This **SUPPLEMENT TO SUBSIDIARY PATENT AND TRADEMARK SECURITY AGREEMENT**, dated as of November 8, 2002 (the "**Patent and Trademark Supplement**"), is delivered pursuant to the Subsidiary Patent and Trademark Security Agreement, dated as of December 18, 1997 (as it may be from time to time amended, restated, modified or supplemented, the "**Subsidiary IP Security Agreement**"), by and among **THE UNDERSIGNED DIRECT AND INDIRECT SUBSIDIARIES** (each of such undersigned Subsidiaries being a "**Grantor**" and collectively "**Grantors**") and **JPMORGAN CHASE BANK, f/k/a The Chase Manhattan Bank** as successor by merger to Morgan Guaranty Trust Company of New York, as **Collateral Agent** (the "**Collateral Agent**"). Unless otherwise defined herein, capitalized terms used herein shall have the meanings ascribed thereto in the Subsidiary IP Security Agreement.

Grantor hereby (a) confirms that the Subsidiary IP Security Agreement and all Collateral encumbered thereby will continue to secure the payment and performance of all Secured Obligations, including without limitation the payment and performance of all Obligations of Grantor whether now or hereafter existing under or in respect of any Financing Agreement, any other Loan Documents and the Lender Interest Rate Agreements, (b) grants to the Collateral Agent a continuing lien on and security interest in all Grantor's right, title and interest in, to and under all Collateral, including without limitation, the Trademarks listed on Schedule I attached hereto (as such schedule may be amended or supplemented from time to time) and the Patents listed on Schedule II attached hereto (as such schedule may be amended or supplemented from time to time), (c) agrees that the lien granted pursuant to the Subsidiary IP Security Agreement and this Patent and Trademark Supplement is a continuing lien and security interest in and to the Collateral and is not a conditional assignment of such Collateral, notwithstanding anything to the contrary in the Subsidiary IP Security Agreement, and (d) authorizes Collateral Agent to: (i) file financing or continuation statements and amendments thereto in any jurisdictions and with any filing offices as Collateral Agent may determine, in its reasonable judgment, are necessary to perfect the security interest granted to Collateral Agent herein or in the Subsidiary IP Security Agreement, and (ii) to record this Patent and Trademark Supplement in all places where the Subsidiary IP Security Agreement is recorded, including the U.S. Patent and Trademark Office. Such financing statements may describe the Collateral in the same manner as described in the Subsidiary IP Security Agreement or may contain an indication or description of collateral that describes such property in any other manner as Collateral Agent may determine, in its reasonable judgment, is necessary, advisable or prudent to ensure the perfection of the security interest in the Collateral granted to Collateral Agent herein and in the Subsidiary IP Security Agreement, including, without limitation, describing such property as "all assets" or "all personal property, whether now owned or hereafter acquired."
