ASSIGNMENT

Said **ASSIGNOR** hereby releases, assigns, and transfers unto said **ASSIGNEE** its successors, assigns and legal representatives, all rights, titles, and interests, claims and demands whatsoever said **ASSIGNOR** had in, to and by, under and through, said trademarks and corresponding registrations thereof, set forth in Schedule "A", including all claims for any and all past infringement thereof and the right to sue therefor;

ALL OF THE SAME to be held and enjoyed by said **ASSIGNEE** for its own use and behoof and for its successors, assigns and legal representatives as fully and

entirely as the same would have been held and enjoyed by said **ASSIGNOR** had this Assignment not been made.
