PURCHASE AGREEMENT

Between :

SOCIETE DES PRODUITS NESTLE S.A., having its head office at 1800 Vevey, Canton of Vaud, Switzerland (hereinafter referred to as NESTLE),

and


B.S.A., a French stock company with board of directors and board of trustees, SIREN 557 350 253, Paris Commercial Register, having its head office at 11 bis, avenue Charles Floquet – 75 007 Paris, France (hereinafter referred to as B.S.A.),

it has been agreed upon that :

1. By this agreement, NESTLE assigns to B.S.A., which accepts, the whole and entire property of U.S.A. trademark registration No. 1358303 PRESIDENT, filed on 23 January 1985 under No. 73518794,
2. NESTLE gives to B.S.A. only the warranty of the existence of the registration of PRESIDENT.
3. The price for this assignment is agreed to be CHF 1500.-- payable within 30 days as of the date of this agreement.
4. NESTLE hereby grants B.S.A. all power necessary to record the assignment of this agreement with the USA Trademark Register at their own cost.


