## RELEASE

This Release is granted on this 14th day of November, 2002 by Bank One, NA (successor by merger to Bank One, Colorado, NA) (*as Assignee* under the Security Agreement described below, and herein referred to as "Assignor"), a national banking association, as agent, in favor of T-NETIX, Inc., a Delaware corporation (formerly known as T-NETIX, Inc., a Colorado Corporation), T-NETIX Monitoring, Inc., a Colorado corporation, SpeakeEZ, Inc., a Colorado corporation, and T-NETIX JMS Corporation, a Colorado corporation (*as Assignor* under the Security Agreement described below, and herein referred to collectively as, "Assignees"), as follows:

WHEREAS, the Assignees entered into a Patent and Trademark Security Agreement dated September 9, 1999, which was recorded in the U.S. Patent and Trademark office on September 29, 1999 at Reel 001967/Frame 0031 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, each of the Assignees pledged and assigned to Assignor, its successors and assigns, a security interest in the Patents and in the Trademarks (as defined in the Security Agreement), and certain other intellectual property including without limitation all goodwill symbolized by and contained in any of the above (the "Collateral") to secure the payment of the Obligations (as defined in the Security Agreement) (the "Obligations");

WHEREAS, the Collateral included the U.S. registered trademarks and applications therefor listed on Schedule A hereto;

WHEREAS, the Collateral included the U.S. registered patents and applications therefor listed on Schedule B hereto;

WHEREAS, the Assignees have repaid in full the Obligations and the Security Agreement has terminated; and

WHEREAS, Assignor therefore desires to release all right, title and interest in, to and under the Collateral.

NOW, THEREFORE, for valuable consideration, including the satisfaction of all obligations and indebtedness of the Assignees, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby agrees as follows:

1. Assignor hereby releases and assigns all right, title, and interest in the Collateral to Assignees and their respective successors and assigns. Assignor hereby acknowledges that any and all Obligations have been paid in full and satisfied and that any and all Assignor liens, encumbrances, and security interests, in and to the Collateral are hereby terminated.

2. The Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to record this release of the security interest in the Collateral and each part thereof.

3. The Assignor hereby agrees to, at the expense of the Assignees, duly execute, acknowledge, procure and deliver any further documents, including, but not limited to, those documents necessary under Article 9 of the Uniform Commercial Code or other applicable law, and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.

4. This Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors and assigns.

5. Assignor hereby acknowledges that Assignees will rely on this Release and will use it as evidence of satisfaction of the Obligation and release of all liens before the United States Patent and Trademark Office and other Federal and state governmental authorities.

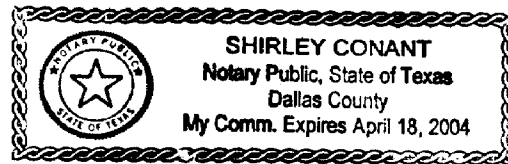
