(Finova Capital Corporation)


ENDURO SYSTEMS, INC. (the "Debtor") and FINOVA CAPITAL CORPORATION ("Secured Party") are parties to a certain Amended, Restated and Consolidated Loan and Security Agreement dated as of August 8, 1995 (as such agreement has been amended or otherwise modified, the "Loan Agreement"). Pursuant to the terms of the Loan Agreement, the Debtor and FW ACQUISITION CO. executed in favor of Secured Party a certain Intellectual Property Security Agreement dated as of November 30, 1999 (the "IP Agreement").
