**RELEASE OF SECURITY INTEREST**

This release of security interest in trademarks, dated as of May 15, 1997 by WILMINGTON TRUST COMPANY, MICHAEL M. LEDYARD and their successors, as Trustees (collectively, the "Trustees").

**RECITALS**

A. Interco Incorporated, Interco Subsidiary, Inc. and certain named Pledgors (the "Company") and Trustees entered into the Security Agreement (as from time to time amended, modified or supplemented in accordance with the terms thereof, the "Security Agreement").

B. Pursuant to the Security Agreement Company granted Trustees a continuing security agreement interest in all of its right, title and interest in and to trademarks that are owned by London Fog Industries, Inc., formerly a subsidiary of Interco Incorporated ("LFI") including but not limited to, those listed on Schedule A attached hereto (the "Trademarks").

C. The Security Agreement was recorded in the United States Patent and Trademark Office on February 16, 1990 at Reel No.: 0722 and Frame No.: 0056.

D. The obligations covered by the Security Agreement have been satisfied and Trustees have no further claim to the Trademarks.

1. NOW THEREFORE, in consideration of the foregoing and the conditions hereinafter set forth, and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Trustees hereby agree that the security interest granted under the Security Agreement in the Trademarks is hereby terminated and of no further force or effort and that they have no right or claim to any trademarks owned by LFI.

2. The Trustees agree that upon written request of LFI, or anyone acting for LFI including, but not limited to, Congress Financial Corporation, the Trustees shall execute such further documents and do such further acts as may be reasonably requested to give effect to this release.
